In consideration of and as inducement to Howell Ski and Board Club's acceptance of my child's participation in any and all events/activities involving the Howell Ski and Board Club, I expressly assume any and all risks of such damage or injury occurring to my child at any and all events/activities, and I hereby release and agree to indemnify, defend, and hold harmless Howell Ski and Board Club and/or Howell Public Schools, and all their related entities, employees, directors, officers, members, volunteers, beneficiaries, venue hosts (including but not limited to Mt Brighton) and agents from any and all liability of any nature, causes of action, debts, claims, and demands of every kind and nature, whatsoever, for injury or damage, which I or any member of my family or any other person accompanying me to said events/activities may incur, or for which I may be liable, and which arises or is alleged to arise in connection with their participation in an event activity involving the Howell Ski and Board Club and/or Howell Public Schools, whether occurring on the event grounds or the surrounding area thereto, or while traveling to or from such grounds or surrounding area.
